RELEASE AND HOLD HARMLESS AGREEMENT

Whereas, Gila Farmers' Market ("Farmers' Market") is an organization whose primary functions include the furtherance of the marketing of local food and providing a venue ("venue") for sellers of local food to market their product ("vendor(s)"); and

Whereas, the Farmers' Market does not have, nor desires, the means to guarantee the quality of the products sold at the venue, nor has the regulatory powers necessary to effectively monitor the activities of its vendors beyond ensuring clean selling places and orderly conduct; and

Whereas, the Farmers' Market finds it appropriate and necessary to disclose its limited functions and responsibilities, and to protect itself for activities beyond its control.

Therefore, prior to using the venue, any vendor at the venue must acknowledge this Agreement and sign on behalf of him/herself this Release and Hold Harmless Agreement, the terms of which are:

1. The vendor agrees that he/she shall hold the Farmers' Market, its directors, employees and agents harmless from any claim, damage, loss, or liability occasioned by the marketing, selling, or conduct at the venue, made by any third party against the Farmers' Market, and will indemnify the Farmers' Market from any loss or damage occasioned thereby.
2. The vendor agrees that he/she will promptly notify the venue manager of any instance wherein harm or damage to the public may have occurred or be occurring by virtue of any vendor's conduct at the venue.
3. The vendor hereby knowingly and voluntarily releases and holds harmless Farmers' Market from any loss, damage, harm, or liability arising out of the aforesaid activities, whether to their person or to their property, however and by whomever caused, except if such loss, damage, or harm has been as a result of the gross negligence of the Farmers' Market or its agents or employees.
4. At each market, a minimum fee of \$5 will be charged for vendors selling \$200 or less. For total sales over \$200, a 5% of total sales fee is required from each vendor up to a max fee of \$30.
